Access to this is from Newtown-Richboro Road at the rear entrance. Please do not use the Green Lane entrance due to a Teachers In-Service Day. Voting/ Elections signs will assist you in locating the new polling place. Drop-off and handicapped parking will be in front of the cafeteria at the curb as indicated by signs. A new parking area has been built.



When entering the building go through the second set of doors and signs will direct you to District #1 or to District #4. Access to the bathrooms is from the hallway between the entrance doors. !

Protect Your Trees Ash Trees

Bucks County is experiencing an infestation of the emerald ash borer, an insect that kills ash trees. There are many ash trees throughout the community, planted by the original developers. Carl Ruzicka has sought the advice of two tree services who have certified arborists on their staffs.

Although the ash trees may not look diseased now, it just takes a year or two before the trees really start to show the effects of the ash borers. There are three primary types of insecticide used. The first, and cheapest, is called *Merit*, a trade name. It is spread on the ground near the root system and it depends on rain to be absorbed into the tree. It takes 6-8 weeks to start having an effect. This treatment needs to be reapplied annually for 3-5 years. The results of *Merit* treatment have been less satisfactory than the following two types.



The second type of treatment is called *Safari* and it is sprayed on the trunks of the tree up to about 5 feet. It is

absorbed through the bark of the tree and then dispersed inside the tree and needs to be applied annually for at least 3 years. The treatment success rate is much better for this product than for *Merit* but both treatments are limited as to how much can be used per acre. Both of these products would be better if applied early in the season as it takes 2-4 weeks for the product to be absorbed by the tree. The leaves of the tree need to be green for the treatment to be dispersed.

The third treatment is called *Triage* and it is the most successful of the three. This pesticide is applied by drilling a hole in the side of the tree and inserting a pellet. The pellet dissolves and disperses the treatment within the tree and needs to be applied only once every three years.

Oak Trees

According to the arborist, many of our oak trees have bacterial leaf scorch. Leaf scorch, sometimes called marginal leaf burn, describes the death of tissue along the edge of the leaf. This symptom develops when sufficient water does not reach the leaf margin cells.

Parts of the tree turn brown while other parts of the tree remain green. There is a treatment that will control the spread of bacterial leaf scorch but will not cure it. Eventually, the entire tree will turn brown and die.

Told the repaving of Mill Pond was not in the budget, Mr. Downey replied, "Budgets aren't carved in granite and stainless steel. Whatever it takes, fix it please." He then stated, "We would like some feedback as to when."
