Emerald Ash Tree Borer

You may have heard that the trails at Clark Nature Center are indefinitely closed or noticed some changes along the trails in Tyler State Park. Unfortunately, Bucks County is experiencing an infestation of the emerald ash borer, an insect that kills ash trees and, although there are some treatments available, in most cases the trees must be cut down.
