#### POOL VANDALISM UPDATE

The Board of Directors is pleased to report that the perpetrators of serious vandalism at our pool have been apprehended. The arrest was through the very capable hands of Detective Camp of the Newtown Township Police Department.

All of the perpetrators are teenagers, ages 16 & 17. On August 11, their cases were adjudicated before Judge Petrucci. The boys were present with their parents. Detective Camp represented the Commonwealth. They were required to do 20 hours of

community service as well as to make restitution of \$3,600. Some of the community service will be performed in Newtown Crossing with the remainder under the supervision of the court.
