Please be considerate and put your trash can in the street for pick up and then return it to your property, and do not block the sidewalk with your car.

Homeowners are responsible for trimming trees and other vegetation that may be blocking sidewalks or overhanging the road.

Who May Use Newtown Crossing's Pool?

Any resident of Newtown Crossing, as long as their assessment fees are not in arrears, may use the community pool after obtaining a pool tag and updated sticker for the current year. "Newtown Crossing" does not include Liberty Square nor Eagle Ridge. Residents may purchase guest passes for non-residents at the pool, but guests must be accompanied by residents. Note: due to the type of chlorine we use, the pool requires occasional partial draining and refilling to reduce cyanuric acid levels which cause the chlorine to become ineffective.
